- provide a broad and balanced curriculum, which challenges your child to reach their potential and fulfils the requirements of the National Curriculum/ Early Years Foundation Stage Statutory Framework
- treat all children fairly regardless of their nationality , race, religion , gender
- encourage your child to show friendship and respect for others and to abide by the school behaviour policy, ensuring a safe, caring environment for all
- keep you informed about your child's academic and personal achievements
- provide clear and consistent high expectations for behaviour in accordance with school behaviour policy
- make you feel welcome whenever you visit the school and respond to your questions or concerns as quickly as possible in a courteous and effective manner
- allow children safe and secure use of the internet through a combination of site filtering, supervision and by fostering a responsible attitude in all pupils, in partnership with parents/carers
- ensure that your child's physical, mental and spiritual well-being are cared for
- process your child's data in accordance with GDPR regulations

## The Responsibilities of the Parents/Carers

All parents/carers will:

- having chosen West Ashton C of E Primary for your child, accept the school's aims and Christian values, positively supporting the school
- ensure that your child attends school punctually every day during term time, unless there is a good reason for absence (e.g. illness)
- ensure you do not take holidays in term time
- support your child in being ready to learn by ensuring they have sufficient rest and breakfast
- notify the school by Parentmail, email or telephone in the event of absence
- support the school's policies and guidelines on learning, behaviour and uniform
- attend parent/teacher meetings to discuss your child's progress
- support your child with homework that is set, including reading
- keep us informed of where to contact you in case of emergency
- promptly inform the school of any concerns or problems that may affect your child's learning, behaviour or happiness at school
- support school in the teaching of safe and secure internet use at home
- help to keep the children safe by parking responsibly outside school
- pay any monies due, such as dinner money, promptly, or inform school if you are experiencing difficulties so that support can be provided
- behave appropriately when on school property and treat the school staff in a reasonable and respectful way
- ensure that your child is dressed according to the school's uniform code and appropriately for the day's activities and weather conditions
- not bring dogs on to the school premises
- communicate with school staff and other adults in a respectful manner
- abide by the school's policy on the use of social media especially in respect of Facebook and other such platforms
